FINAL ORDER

NOW ON THIS 23rd Day of April 2005, this matter comes on for hearing. Respondent Lori L. Stonehocker appears in person and through Michael E. Francis, Attorney at Law. Stacy L. Cook, Litigation Counsel, appears for the Board.

This matter is related to a disciplinary proceeding under the same name, Docket No. 04-HA-59. That case was initiated by a petition that alleged multiple instances of improper practice. The case was resolved with a consent agreement filed on October 18, 2004. The Board now alleges that Respondent violated the terms of the agreement. Respondent requests that she be allowed to surrender her license. Board Counsel objects to allowing such surrender.

Having the agency record before it, the Board finds, concludes and orders as follows:

1. The facts in this proceeding are not in dispute. Respondent agreed in the October order to pay a \$5000 fine, to attend a board-approved record keeping course, to complete a clinical skills assessment at CPEP, and to maintain her license. Respondent has not adhered to these requirements.

2. The Board denies Respondent's request to surrender her license.

3. The Board finds and concludes that Respondent's license should be revoked for failure to comply with the prior orders.

IT IS, THEREFORE, ORDERED that the license of Lori L. Stonehocker, D.O. is hereby revoked.

PLEASE TAKE FURTHER NOTICE that this is a final order. A final order is effective upon service. A party to an agency proceeding may seek judicial review of a final order by filing a petition in the District Court as authorized by K.S.A. 77-601, et seq. Reconsideration of a final order is not a prerequisite to judicial review. A petition for judicial review is not timely unless filed within 30 days following service of the final order. A copy of any petition for judicial review must be served upon the Board's Executive Director at 235 SW. Topeka Blvd., Topeka, KS 66603.
