SUMMARY ORDER

Upon review of the agency record and being duly advised in the premises, the following findings of fact, conclusions of law and order are made for and on behalf of the Board:

Findings of Fact

- 1. Shelley A. Stroup, O.T.A. ("Licensee") was originally issued license number 18-00005 to practice as an occupational therapy assistant in the state of Kansas on August 15, 1987. Licensee's license is currently active.
- 2. Licensee's last known mailing address as provided to the Board at the time of her application for reinstatement is 4100 Bell Ct., Garden City, Kansas 67846.
- 3. On or about April 2, 2009, the Board received an application from Licensee for reinstatement of her occupational therapy assistant license. Licensee's license had been cancelled for

failure to renew on May 1, 2008.

- 4. In section 6 of her application, Licensee lists all professional activities since the cancellation of her license. Licensee states that she worked as a COTA/L for USD #457 from April 1, 2008 to present. Licensee further explains that "I did not realize until the end of March 2009, that I had not renewed for 2008. No correspondence was ever received from KSBHA."
- Licensee's license was reinstated on April 20, 2009. Licensee worked from May 1,
 2008 until April 20, 2009 as an occupational therapy assistant without being properly licensed.

Applicable Law

- 6. K.S.A. 65-5410 states, in pertinent part: (a) The Board may deny, refuse to renew, suspend, revoke or limit a license or the licensee may be publicly or privately censured where the licensee or applicant for licensure has been guilty of unprofessional conduct which has endangered the health, welfare or safety of the public. Unprofessional conduct includes:
 - (2) being guilty of unprofessional conduct as defined by rules and regulations adopted by the board;
 - (c) The board, in addition to any other penalty prescribed in subsection (a), may assess a civil fine, after proper notice and an opportunity to be heard, against a licensee for unprofessional conduct in an amount not to exceed \$5000 for the first violation. . . .
- 7. K.A.R. 100-54-5 Unprofessional conduct; defined. Unprofessional conduct means any of the following:
 - (o) committing conduct likely to deceive, defraud or harm the public

Conclusions of Law

8. The Board has jurisdiction over Licensee as well as the subject matter of this proceeding, and such proceeding is held in the public interest.

- 9. That by continuing to be employed as an occupational therapy assistant from May 1, 2008 to April 20, 2009, Licensee was holding herself out to the public as an individual properly licensed by the Kansas State Board of Healing Arts to assist in the practice of occupational therapy, by doing so Licensee engaged in conduct likely to deceive, defraud or harm the public in violation of K.S.A. 65-5410(2) in combination with K.A.R. 100-54-5.
- 10. The Board finds that Licensee engaged in unprofessional conduct as defined by K.A.R. 100-54-5 by continuing to be employed as an occupational therapy assistant without being properly licensed.
- 11. Based on the facts and circumstances set forth herein, it appears that the use of summary proceedings in this matter is appropriate, in accordance with the provisions set forth in K.S.A. 77-537(a), in that the use of summary proceedings does not violate any provision of the law and the protection of the public interest does not require the Board to give notice and opportunity to participate to persons other than Licensee, Shelley A. Stroup, O.T.A.

IT IS, THEREFORE, ORDERED that Licensee is hereby assessed a civil fine of \$350 due and payable within thirty days of the effective date of this Order.

NOTICE AND OPPORTUNITY FOR HEARING

PLEASE TAKE NOTICE that this is a Summary Order. A party to whom a Summary Order is issued may file a written request for a hearing pursuant to K.S.A. 77-542 within 15 days following service of the Summary Order. Such written request shall also state the legal and/or factual basis upon which the party opposes this Order. If a hearing is not requested, the Summary Order shall become effective as a Final Order of the Board upon expiration of the time for requesting a hearing.
