JOURNAL ENTRY

NOW on the 8th day of February, 1992, this matter comes on for consideration on request of the Kansas State Board of Healing Arts (Board) by and through its attorney, Steve A. Schwarm, Litigation Counsel, to terminate the second temporary permit relative to the June 19, 1991 ORDER GRANTING SECOND TEMPORARY PERMIT involving Debra S. Stuart, P.A. (Registrant).

The Board appears through Steve A. Schwarm, Litigation Counsel; there are no other appearances.

The Board takes administrative notice of the official agency file to include May 24, 1991 NOTICE OF CONFERENCE HEARING and June 19, 1991 ORDER GRANTING SECOND TEMPORARY PERMIT to Registrant.


Under the provisions of the June 19, 1991 ORDER GRANTING SECOND TEMPORARY PERMIT, paragraph 6, reflects in part that Registrant should be granted a second temporary registration until the Board receives results from the NCCPA examination given in

October, 1991. Additionally, on page 2 of the June 19, 1991 ORDER GRANTING SECOND TEMPORARY PERMIT, it states in part, "It is further ordered that in the event that Registrant fails to pass the NCCPA examination to be administered in October, 1991, the second temporary registration hereby granted to Registrant should expire and be cancelled as of the date the failure becomes available to the Board."

Information has been proffered to the Board by its counsel that Registrant failed the NCCPA examination administered in October, 1991. Such proffer is evidenced by the official results forwarded to the Board and received by the Board Licensing Supervisor who is charged with receipt of such records regarding registration of physician assistants in the State of Kansas.


It is therefore ordered that based upon the conditions of the June 19, 1991 ORDER GRANTING SECOND TEMPORARY PERMIT that such temporary permit shall be and hereby cancelled based on the terms of the June 19, 1991 ORDER GRANTING SECOND TEMPORARY PERMIT and such temporary registration shall be surrendered to the Board within seven (7) calendar days by certified mail after service of this Journal Entry. Upon receipt of this Journal Entry, it is further ordered that Registrant shall cease to represent herself as a physician assistant in the State of Kansas until such time that Registrant comes into compliance with all provisions of the Kansas Physician Assistant Act as may be in place at the time that she makes proper application.

IT IS SO ORDERED on this 8th day of February, 1992.


