FINAL ORDER FOLLOWING CONFERENCE HEARING

NOW on this 6th day of December, 1997, this matter comes on for conference proceedings before the full Board at the request of William Marco A. Suleiman, M.D. (hereinafter "Applicant") to waive the requirement of Section X, Certificate of Professional College, of the Application for Endorsement.

Charlene K. Abbott, Licensing Administrator, presents the information to the Kansas State Board of Healing Arts (hereinafter "Board"). Applicant appears in person <u>pro se</u>. There are no other appearances.

After reviewing the file, hearing statements of the Licensing Administrator and Applicant and being duly advised in the premises, the Board make the following findings of fact, conclusions of law and orders:

- 1. Applicant's Application for Endorsement was received on January 23, 1996.
- 2. Applicant requests waiver of the Section X requirement of the Application for Endorsement due to the political tension at the present time between the United States and Iraq.
- 3. Notice of Conference Hearing setting this matter for 2:30 p.m. on December 6, 1997 was filed herein on November 21, 1997 and served on Applicant on that same date.

4. Applicant has been unable to obtain certified documents from Mosul University College

of Medicine, Iraq, to satisfy the requirement of Section X of the Application for Endorsement.

5. Applicant has been licensed to practice medicine and surgery in the states of Nebraska,

Ohio, Michigan, Indiana, Illinois and New York.

6. The Board has determined that the information provided by Applicant in support of the

application in substantial conformity with K.A.R. 100-8-2(e) and therefore, sufficient cause exists to

waive the Section X requirement on Applicant's Application for Endorsement.

IT IS THEREFORE ORDER, ADJUDGED AND DECREED that the requirement of

Certification of Professional College, or Section X of Applicant's Application for Endorsement, is

hereby waived.

IT IS FURTHER ORDERED that waiver of the Section X requirement does not constitute

approval of Applicant's Application for Endorsement, nor does it constitute a waiver of any other

requirement of the application. Applicant's Application will not be considered by the Board at such

time as it has been deemed complete, with the exception of the Section X certification.

IT IS FURTHER ORDERED that this is a Final Order and is effective upon service upon

the parties. Any party may, within fifteen (15) days after service, file a Petition for Reconsideration.

The filing of a Petition for Reconsideration is not a prerequisite for seeking administrative or judicial

review.

IT IS SO ORDERED.
