FINAL ORDER FOLLOWING CONFERENCE HEARING

NOW, on this 18th day of October, 1997, this matter comes on before the Kansas State Board of Healing Arts (hereinafter "Board") sitting as a whole, the application of Dorairaj Suresh, M.D., (hereinafter "Applicant") for a permanent license to practice medicine and surgery in the State of Kansas.

Applicant appeared pro se. Charlene Abbott, Licensing Administrator of the Board, presented information to the Board.

After reviewing the file, hearing statements and being otherwise duly advised in the premises, the Board finds as follows:

1. On December 2, 1996, Applicant filed an Application For Endorsement to obtain a permanent license to practice medicine and surgery in the State of Kansas.

2. As part of that application, Applicant provided information and documentation regarding postgraduate training which had been obtained by Applicant. The information provided by Applicant reflected he had obtained more than 2 years postgraduate training in the United Kingdom.

3. The Board reviewed the application and determined that it was complete insofar as the information which had been provided by Applicant regarding his postgraduate training was acceptable to the Board to satisfy the requirements of K.A.R. 100-6-2.

4. Applicant is licensed in the States of Missouri and North Carolina and is eligible for a license by endorsement under K.S.A. 65-2833.

IT IS THEREFORE ORDERED as follows:

a) That the findings here and above made be in the same are made the Order of the Board.

b) Applicant has met the requirements of K.A.R. 100-6-2 in that he has provided evidence of completion of 2 years of postgraduate training approved by the Board.

(c) Applicant's application be placed on the list for approval of licensure to practice medicine and surgery, such list to be presented to and acted upon by the Board at its December 5-6, 1997 regular meeting.

(d) Either party is entitled to an administrative review of this Order if written request is received in the Board office within fifteen (15) days of service of this Order upon the parties.

IT IS SO ORDERED.


