FINAL ORDER

NOW on this 15th day of February, 1997, this matter comes on for conference proceedings before the Board upon the request of Michael Sutters, M.D. (hereinafter "Applicant") to grant a license to practice medicine and surgery, pursuant to K.S.A. 65-2801 *et. seq.* There are no appearances.

Charlene K. Abbott, Licensing Administrator, presents information to the Kansas Board of Healing Arts (hereinafter "Board").

After reviewing the file, hearing statements of the parties and being duly advised in the premises, the Board makes the following findings of fact, conclusions of law and orders:

1. An application for endorsement was received from Applicant on September 23, 1996.
2. Notice of Conference Hearing setting this matter for hearing at 11:30 a.m., Saturday, February 15, 1997, was filed herein on January 31, 1997 and served on Applicant on that same date.
3. Applicant attended the University of London, receiving a Bachelor's degree in medicine and surgery, and has had several years of training as an intern, resident, and research fellow.

4. Applicant is unable to furnish transcripts, and asks the Board to waive the transcript requirement.

5. Applicant has provided information substantially equivalent to that contained in a transcript.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED as follows:

A. Applicant's request to waive the requirement of producing a medical school transcript is granted. Upon completion of all other portions of the application process, Applicant will be deemed eligible for consideration for licensure.

B. That this is a Final Order and is effective upon service upon the parties. Any party may, within fifteen (15) days after service, file a Petition for Reconsideration. The filing of a Petition for Reconsideration is not a prerequisite for seeking administrative or judicial review.

IT IS SO ORDERED.
