SUMMARY ORDER

NOW on this 22nd day of June, 1996, comes before the Board of Healing Arts (hereafter "Board") for summary proceedings on the Application for Endorsement submitted by Steven R. Taraszka, M.D. (hereafter "Applicant"), and the Board's Petition for Summary Order to Deny or Limit License submitted by Assistant General Counsel Shelly Gasper.


After reviewing the record before it, the Board finds as follows:

1. Applicant's Application for Endorsement was submitted on July 3, 1995.
2. A Petition for Summary Order to Deny or Limit License was filed herein by the Board on June 10, 1996.
3. Applicant voluntarily surrendered his license in Vermont effective February 8, 1996 based in part on an admission of chemical addiction.

5. Applicant has surrendered his license to practice the healing arts in another state for conduct which would constitute grounds for disciplinary action here, K.S.A. 65-2836(u).
6. Applicant is unfit to practice the healing arts in Kansas pursuant to K.S.A. 65-2836.

WHEREFORE, Applicant's Application for Endorsement is hereby **DENIED**.
