ORDER OF RETROACTIVE ISSUANCE OF TEMPORARY PERMIT

NOW, on this 17th day of April, 1993, comes on for consideration before the Kansas State Board of Healing Arts, sitting as a whole as Presiding Officer in a Conference Proceeding pursuant to the provisions of K.S.A. 77-533, the request of Hanan Kathy Tawadros, M.D., (hereafter "Licensee") for retroactive issuance of a temporary permit under K.S.A. 65-2811(a)(1). Licensee did not appear.

After reviewing the request and being otherwise duly advised in the premises, the following findings are made:

1. Licensee was issued a postgraduate training permit under K.S.A. 65-2811(a)(3) to be effective July 1, 1991 through June 30, 1995 which limited Licensee's practice to a postgraduate training program but did not authorize or permit Licensee to engage in private practice.

2. Licensee was mailed an application for permanent license and said application was received in the Board office July 9, 1992 and deemed complete on August 20, 1992. A permanent license to practice medicine and surgery was issued to Licensee on October 31, 1992.

3. Payment of temporary permit fee for a permit under K.S.A. 65-2811(a)(1) was not received until April 12, 1993.

4. Licensee actively engaged in the practice of medicine and surgery in the state of Kansas outside of her postgraduate training program from August 20, 1992 until permanent license was issued on October 31, 1992 and therefore requests that a temporary permit be issued under K.S.A. 65-2811(a)(1) for such period of time.

6. It was due solely to inadvertence and mistake that Licensee did not pay the necessary temporary permit fee in order to meet the qualifications for a temporary permit under K.S.A. 65-2811(a)(1) until April 12, 1993.

IT IS THEREFORE BY THE BOARD ORDERED AS FOLLOWS:

A. That the findings here and above made be and the same are made the order of the Board.

B. A temporary permit be retroactively issued under K.S.A. 65-2811(a)(1) to Hanan Kathy Tawadros, M.D., to practice medicine and surgery in the state of Kansas outside of her postgraduate training program for the period August 20, 1992 through October 31, 1992.

C. This is a Final Order and is effective upon service upon the parties. Any party may, within 15 days after service, file a Petition for Reconsideration. The filing of a Petition for Reconsideration is not a prerequisite for seeking administrative or judicial review.

IT IS SO ORDERED.
