COMES NOW the Kansas State Board of Healing Arts (“Board”), by and through its Executive Director, Kathleen Selzler Lippert, a duly authorized representative of the Board, in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501 *et seq.*, as amended, and upon due consideration of the agency record and applicable statutes and regulations, and being otherwise duly advised in the premises, makes the following determinations:

1. On or about June 18, 2013, Licensee entered into a Consent Order with the Board for alleged violations of the Kansas Podiatry Act, K.S.A. 65-2001, *et seq.* The Consent Order required Licensee attend and successfully complete the ProBe Course offered by the Center for Personalized Education for Physicians (“CPEP”). Licensee was to provide the Board with documentation evidencing completion of the courses by November 15, 2013.

2. On or about November 18, 2013, Licensee submitted documentation evidencing completion of the ProBe Course, presented by the Center for Personalized Education for Physicians.


3. Licensee has satisfactorily met all requirements of the Consent Order and has no further obligation for compliance.


