FINAL ORDER FOLLOWING CONFERENCE HEARING

NOW, on this 29th day of April, 1995, comes on for consideration before the Kansas State Board of Healing Arts (hereafter "Board") sitting as a whole as Presiding Officer in a conference proceeding pursuant to the provisions of K.S.A. 77-533 through 77-535, the Application of Thomas R. Taylor, D.C. (hereafter "Applicant") for licensure to practice chiropractic in the State of Kansas. Gretchen E. Schmidt, Associate Counsel, appears for and on behalf of the Board. Applicant appears pro se.

After reviewing the application and being otherwise duly advised in the premises, the Board finds as follows:

1. Applicant was originally registered as a respiratory therapist in the State of Kansas on August 15, 1987 and was subsequently cancelled on February 1, 1989 due to non-renewal.
2. On November 4, 1992, a Consent Agreement was entered into between the Board and Applicant to resolve an investigation

conducted by the Board into allegations that Applicant had represented himself a registered respiratory therapist in the State of Kansas from February 1, 1989 to March 20, 1992 without proper respiratory therapy registration through the Board. Applicant reinstated his respiratory therapy registration on October 31, 1992 and that registration expired on December 31, 1993 and was cancelled on February 22, 1994 due to non-renewal.

3. On July 22, 1994, Applicant submitted an Application for Endorsement to practice chiropractic in the State of Kansas. On said application, Applicant answered affirmative to questions posed in section **VI DISCIPLINARY**.

4. On April 29, 1995, a Conference Hearing was held in the above-captioned matter to enable Applicant to submit additional information to the Board prior to the Board taking final action on Applicant's application for licensure by endorsement.

CONCLUSIONS OF LAW

Upon review of the application and the investigation results, the Board finds insufficient reason to deny Applicant's application for licensure by endorsement to practice chiropractic under K.S.A. 65-2836.

IT IS THEREFORE BY THE BOARD ORDERED as follows:

a) That the findings herein above made be and the same are made the Order of the Board.

b) That Applicant's Application for Endorsement in the State of Kansas should be placed on the Board agenda for final approval and issuance of a permanent license at the next regularly

approval and issuance of a permanent license at the next regularly scheduled meeting of the Board.

c) This is a Final Order and is effective upon service upon the parties. Any party may, within fifteen (15) days after service, file a Petition for Reconsideration. The filing of a Petition for Reconsideration is not a prerequisite for seeking administrative or judicial review.

IT IS SO ORDERED.
