JOURNAL ENTRY OF SATISFACTION


COMES NOW the Kansas State Board of Healing Arts (“Board”), by and through its Executive Director, Kathleen Selzler Lippert, a duly authorized representative of the Board, in accordance with K.S.A. 77-501, *et seq*, and upon due consideration of the agency record, applicable statutes and regulation, and being duly advised in the premises, makes the following determinations:

1. On November 2, 2016, Brad Temple, D.C. (“Licensee”) entered into a Consent Order as a condition of reinstatement of licensure.
2. The Consent Order assessed a fine in the amount of \$2,500.
3. The Consent Order was ratified by the Board on September 1, 2017. The Board amended the civil fine from \$2,500 to \$1,000.
4. On September 8, 2017, the Board received a \$1000 payment for the civil fine assessed in Consent Order as modified by the Board’s ratification of the Consent Order.
5. Licensee has met all requirements of the Consent Order and has no further obligation for compliance.

IT IS THEREFORE ORDERED that Licensee is hereby discharged from all requirements of the Consent Order.


