

surgery in the State of Kansas and most recently renewed November 1, 1989 for the period ending June 30, 1990.

3. The Disciplinary Counsel for the Board has caused to be investigated certain matters which may constitute a violation of K.S.A. 1989 Supp. 65-2836 for which the Board has jurisdiction to initiate proceedings to revoke, suspend or limit the license of Licensee pursuant to K.S.A. 1989 Supp. 65-2838.

4. The Board takes administrative notice the investigation conducted and proceedings to date have been proper and in accordance with the Healing Arts Act and the Kansas Administrative Procedures Act.

5. In lieu of the investigative material being presented to the Board and the possibility of filing of formal charges and the initiation of administrative proceedings pursuant to the Kansas Administrative Procedures Act. Licensee by a hand-written statement dated April 26, 1990, requested to voluntarily surrender her license to practice medicine and surgery in the State of Kansas.

6. There appears to be no disputed issue of material fact, the sole issue being whether to accept Licensee's request to voluntarily surrender her license.

7. The Board, having reviewed the record herein, finds the unconditional surrender of the license of Licensee should be accepted.

IT THEREFORE BY THE BOARD ORDERED that the surrender of the license to practice medicine and surgery in Kansas held by Judith

Tharp, M.D., being license number 14292 should be accepted and said license is hereby considered to be revoked and Licensee directed to forward to the Board her original license certificate and most recent renewal receipt by certified mail within seven days of receipt of this Order.

Notice Regarding Relief From This Order



IT IS SO ORDERED.




