FINAL ORDER TERMINATING MONITORING

NOW, on this 21st day of October 2011, comes before the Kansas State Board of Healing Arts ("Board") the Petition of Andrea Tjaden, LR.T. ("Licensee") for termination of the monitoring conditions set forth in the terms of a Consent Order in Docket No. 10-HA00056 which were extended by a Final Order of the Board filed March 11, 2011. Licensee appears in person and by and through counsel, Carol Ruth Bonebrake of Holbrook & Osborn. Stacy Bond, Associate Litigation Counsel, appears on behalf of the Respondent Board.

Pursuant to the authority granted to the Board by the Kansas Healing Arts Act, K.S.A. 65-2801, *et seq.*, and in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501, *et seq.*, the Board hereby enters this Final Order following a conference hearing in the above-captioned matter. After reviewing the file, hearing the testimony and arguments of the parties, and being otherwise duly advised in the premises, the Board makes the following findings, conclusions and order:

1. Andrea Tjaden, L.R.T. ("Licensee"), is licensed to engage in the practice of radiologic technology in the State of Kansas, License No. 22-03571, and has been so licensed since approximately October 16, 2009.
2. On or about October 19, 2009, Licensee entered into a Consent Order ("2009 Consent Order") with the Board confidential

condition of being granted licensure in Kansas.

3. On or about August 30, 2010, a Petition was filed alleging that Licensee had violated the terms of the 2009 Consent Order confidential confidential

4. On or about March 11, 2011, a Final Order was issued extending the terms and conditions of the 2009 Consent Order for at least one (1) year from the original termination date and ordering Licensee to pay Board costs in the amount of \$250.00.

5. On or about April 12, 2011, the Board received confidential stating that Licensee was in compliance with her monitoring contract.

6. On or about July 15, 2011, the Board received confidential stating that Licensee was in compliance with her monitoring contract.


7. On or about August 24, 2011, Licensee petitioned the Board to terminate the monitoring terms which were agreed upon by Licensee in the 2009 Consent Order and extended in the Final Order of March 11, 2011.

8. On September 21, 2011, the Respondent Board filed a neutral Response to Licensee's Petition.


9. Licensee has satisfactorily met all requirements of the Final Order filed March 11, 2011.

IT IS THEREFORE ORDERED, BY THE KANSAS STATE BOARD OF HEALING ARTS, that Licensee has satisfied all terms and conditions contained in the Final Order of March 11, 2011, and that Licensee's Petition to terminate the monitoring conditions agreed to in the 2009 Consent Order is hereby granted.


