**ORDER DENYING EXTENSION OF INSTITUTIONAL LICENSE**  
**KANSAS STATE BOARD OF HEALING ARTS**

NOW, on this 13th day of April, 1991, comes on for conference proceedings the request of Aurora P. Trabajo, M.D. (hereafter "Licensee") for an extension of Institutional License.

Licensee appears in person pro se. The Board appears by and through its Litigation Counsel, Steve A. Schwarm. There were no other appearances.

After reviewing the file and being otherwise duly advised in the premises, the Kansas State Board of Healing Arts (hereafter "Board") makes the following findings of fact and orders:

1. A request for an extension of Institutional License was filed by Licensee on February 22, 1991.

2. Notice of Conference Hearing was filed and served on Licensee on April 1, 1991, setting this matter for hearing on April 13, 1991 at 9:00 a.m.

3. Institutional License No. IL-201 has previously been issued to Licensee and expired on April 4, 1991, but was administratively extended to April 13, 1991.

4. Licensee has not successfully completed the examination required under subsection (a)(3) of K.S.A. 65-2873.

5. Extension of Institutional License No. IL-201 should be denied for the reason Licensee does not meet the requirements for renewal as set forth in K.S.A. 1990 Supp. 65-2895.


IT IS THEREFORE ORDERED BY THE BOARD that the request for an extension of Institutional License NO. IL-201 be denied and that said Institutional License be immediately cancelled and of no further effect.

IT IS FURTHER ORDERED that this is a Final Order and is effective upon service upon the parties. Any party may, within 15 days after service, file a Petition for Reconsideration. The filing of a Petition for Reconsideration is not a prerequisite for seeking administrative or judicial review.
