FINAL ORDER GRANTING LICENSURE

NOW on this 23rd day of June, 1995, this matter comes on for consideration before the Kansas State Board of Healing Arts ("Board") sitting as a whole in a conference proceeding pursuant to the provisions of K.S.A. 77-533 through 77-535, the application of Julie R. Trout, D.C. ("Applicant") for licensure. Kevin K. LaChance, Disciplinary Counsel, appears for and on behalf of the Board. Applicant appears in person.

After reviewing the application, hearing statements of Applicant and Disciplinary Counsel, and being otherwise duly advised in the premises, the Board finds as follows:

- 1. On October 8, 1993, Applicant submitted her application for licensure to practice chiropractic in the State of Kansas. All statutory requirements to apply for said licensure have been completed.
- 2. The Board has considered all information pertaining to Applicant's application for licensure, and votes unanimously to accept Applicant's Application for Licensure as complete and without outstanding issues for consideration.

IT IS THEREFORE BY THE BOARD ORDERED as follows:

A. That the findings here and above made be and the same are made the Order of

the Board.

B. Applicant's application should be placed on he Board agenda for final approval

and issuance of a permanent license at the next regularly scheduled meeting of the Board; in the

interim Applicant, having paid the appropriate fee, is entitled to receive a temporary permit

under K.S.A. 65-2811(a)(1).

C. This is a Final Order and is effective upon service upon the parties. Any party

may, within fifteen (15) days after service, file a Petition for Reconsideration, stating the

specific grounds upon which relief is requested. The filing of a Petition for Reconsideration is

not a prerequisite for seeking administrative or judicial review.

IT IS SO ORDERED.
