ORDER OF RETROACTIVE REINSTATEMENT OF REGISTRATION

NOW, on the Sixth Day of April, 2002, this matter comes on for conference proceedings before the Board of Healing Arts ("Board"), the request of Angie Truong, P.T. ("Applicant") regarding her request for retroactive reinstatement of registration as a Physical Therapist.

Charlene K. Abbott, Licensing Administrator, presents information to the Board. Applicant appears in person.

Having the record before it, the Board finds, concludes and orders as follows:

1. Applicant was originally granted registration as a Physical Therapist on November 28, 2000.
2. Applicant's registration was canceled on February 1, 2002 for failure to renew.
3. Applicant completed the renewal and paid the reinstatement fee and was reinstated February 11, 2002.
4. Applicant's failure to properly renew her registration prior to cancellation on February 1, 2002 was due solely to inadvertence, negligence and mistake and was not due to any intentional conduct on the part of Applicant.

IT IS THEREFORE ORDERED AS FOLLOWS:

**ORDER GRANTING RETROACTIVE REINSTATEMENT
ANGIE T. TRUONG, P.T.**

1. That the findings here and above made be and the same are made the order of the Board.
2. That registration number 11-02945 of Angie Truong to practice physical therapy in the State of Kansas originally reinstated February 11, 2002 be made effective retroactively from and after February 1, 2002.
