FINAL ORDER GRANTING LICENSURE BY ENDORSEMENT

NOW on this 19th day of October 2012, comes before the Kansas State Board of Healing Arts ("Board") the application of Sarah Tsai, M.D. ("Applicant") for licensure by endorsement to practice medicine and surgery in the State of Kansas. Applicant appears via telephone conference. Reese Hays, Litigation Counsel, appears on behalf of the Respondent Board.

Pursuant to the authority granted to the Board by the Kansas Healing Arts Act, K.S.A. 65-2801, *et seq.*, and in accordance with the provisions of the Kansas Administrative Procedure Act K.S.A. 77-501, *et seq.*, the Board hereby enters this Final Order in the above-captioned matter. After reviewing the file, hearing the statements and arguments of the parties, and being otherwise duly advised in the premises, the Board makes the following findings, conclusions and order:

- 1. On or about May 11, 2012. Applicant submitted an application for licensure by endorsement to practice medicine and surgery in the State of Kansas. Such application was deemed complete and filed with the Board on or about September 24, 2012.
- 2. In May of 2005, Applicant graduated from Memorial University of Newfoundland in Canada.
- 3. Applicant passed both parts of the Medical Council of Canada Qualifying Examination (MCCQE) to be registered as a Licentiate of the Medical Council of Canada

("LMCC") between 2005 and 2006, and the LMCC is generally recognized by the Kansas State

Board of Healing Arts as an acceptable equivalent for examination.

4. Applicant successfully completed three (3) years of postgraduate training at

Memorial University of Newfoundland in St. John's, Newfoundland, Canada, between July 1,

2005 and June 30, 2008, which is accredited by the Royal College of Physicians and Surgeons of

Canada (RCPSC). Applicant then participated in an RCPSC accredited fellowship at Children's

Hospital of Eastern Ontario in Ottawa, Ontario, Canada in Pediatric Endocrinology from July

2008 to August 31, 2011.

5. Applicant is currently licensed to practice medicine in Canada, having been

licensed on July 1, 2008. There are no reported disciplinary actions against Applicant's

Canadian license.

6. Applicant is currently licensed to practice medicine in Missouri, having been

licensed on April 5, 2012. There are no reported disciplinary actions against Applicant's

Missouri license.

7. Since being licensed in Missouri, Applicant has practiced pediatric endocrinology

at Children's Mercy Hospital in Missouri. The Board is familiar with that hospital and finds that

the standards for staff privileges at Children's Mercy Hospital are sufficient to demonstrate that

Applicant is competent to practice in Kansas.

8. The Board finds that Applicant has demonstrated satisfactory fulfillment of

K.S.A. 65-2833 to be granted a license by endorsement to practice medicine and surgery in the

State of Kansas.
