JOURNAL ENTRY OF NON-RATIFICATION AND ORDER OF CONTINUANCE

NOW, on this 13th day of December, 2013, this matter comes before the Kansas State Board of Healing Arts (“Board”) for presentation of a Consent Order to be ratified by the Board. Applicant appears in person and *pro se*. Jessica Bryson, Associate Litigation Counsel, appears in person on behalf of the Respondent Board.

Whereby, the parties announce the withdrawal of the Consent Order and request the matter be continued for further proceedings. After reviewing the agency record and hearing the statements of the parties, and being duly advised in the premises, the Board makes the following determinations:

1. Applicant submitted an application for licensure as a radiologic technologist which was determined to be complete and filed with the Board on November 6, 2013.
2. A Consent Order was filed with the Board on November 15, 2013, which granted Applicant a temporary license, T-03807, to practice as a radiologic technologist until December 13, 2013.
3. Presentation of the Consent Order was placed on the Board’s December 13, 2013 meeting agenda for possible ratification by the Board. If ratified by the Board, the Consent Order would have granted Applicant full licensure.

4. Based on changed circumstances, the parties withdrew the Consent Order from presentation for possible ratification by the Board. The parties anticipate presenting a new consent order for consideration by the Board or going forward with conference hearing proceedings on Applicant's application for licensure and request the matter be continued to the February 14, 2014 meeting.

5. The Consent Order filed November 15, 2013, is not ratified by the Board. Additionally, Applicant's temporary license, T-03807 was canceled on December 13, 2013, pursuant to the terms of the Consent Order. Applicant's application for licensure remains pending before the Board.

6. This matter shall be continued to the Board meeting scheduled for February 14, 2014, at a time to be later specified, for presentation of a new consent order or for conference hearing proceedings on Applicant's application for licensure.


