FINAL ORDER TERMINATING LIMITATION

NOW on this 13th day of December 2013, comes before the Kansas State Board of Healing Arts (“Board”) the request of Salvador Valldeperas, M.D. (“Licensee”) for termination of the limitation on his license set forth in the Amended Consent Order filed on September 25, 2012. Licensee appears in person and *pro se*. Jane Weiler, Associate Litigation Counsel, appears on behalf of the Respondent Board.

Pursuant to the authority granted to Board by K.S.A. 65-2801 *et seq.* and in accordance with the provisions of the Kansas Administrative Procedure Act K.S.A. 77-501 *et seq.*, the Board hereby enters this Final Order in the above-captioned matter. After reviewing the agency record, hearing the statements and arguments of the parties, and being otherwise duly advised in the premises, the Board makes the following findings, conclusions and order:

1. Licensee is licensed to engage in the practice of medicine and surgery in the State of Kansas, having been issued License No. 04-35373.

2. On or about September 25, 2012, Licensee entered into an Amended Consent Order with the Board to resolve concerns regarding the length of Licensee’s absence from the active practice of medicine and surgery. The Amended Consent Order limited Licensee’s license in that it required him to enter into and strictly comply with an Education Intervention Program with the Center for Personalized Education for Physicians (“CPEP”) which was developed based on a previous assessment by CPEP of Licensee’s clinical skills.

3. On October 30, 2012, the Board accepted and ratified the Amended Consent Order.

4. The terms of the Amended Consent Order allow Licensee to petition the Board for modification or termination after successful completion of the Educational Intervention Program, Education Plan.

5. Licensee initiated his CPEP Educational Intervention Program on September 1, 2012, and successfully completed the program in September 2013.

6. On or about September 30, 2013, CPEP submitted the final CPEP report regarding Licensee's Educational Intervention Program, Education Plan.


7. On October 1, 2013, Licensee submitted a request to the Board for termination of the limitation contained in the Consent Order.

8. On November 15, 2013, the Respondent Board filed a Response to Petition for Termination of Limitations and offered documentary evidence of Licensee's successful completion of his CPEP Educational Intervention Program.

9. Based on the evidence presented, the Board finds that Licensee has satisfactorily met all requirements of the Consent Order and concludes that termination of the limitations is warranted.

IT IS THEREFORE ORDERED, BY THE KANSAS STATE BOARD OF HEALING ARTS that the **LIMITATION** on Licensee's license set forth in the Amended Consent Order filed on September 25, 2012, is hereby **TERMINATED**.


