FINAL ORDER FOLLOWING CONFERENCE ORDER

NOW, on this 3rd day of June, 1994, this matter comes on for Conference Proceeding before the of State Board of Healing Arts (hereafter "Board") sitting as a whole the request of Jhansi R. Vasireddy, M.D., (hereafter "Permittee") for an extension of post-graduate temporary permit issued to him June 21, 1993.

Permittee appears not. Charlene K. Abbott, Licensing Administrator, appears on behalf of the Board. There are no other appearances.

After reviewing the files and being otherwise duly advised in the premises, the Board makes the following Findings of Fact, Conclusions of Law and Order:

1. That on May 6, 1994, the Board received a letter from Permittee requesting that the temporary permit issued to Permittee under K.S.A. 65-2811(a)(3) be extended for a period of time.

2. Notice of Conference Hearing setting this matter for hearing at 12:45 p.m. on June 3, 1994 was filed herein on May 20, 1994 and served upon Permittee.

3. That pursuant to K.S.A. 65-2811(a)(3) a permit issued under said section "shall be valid for a period of one year following the date of issuance." Further, no more than one temporary permit under said section can be issued to any one person.


**IT IS THEREFORE ORDERED** that the request for extension of the temporary permit from and after June 21, 1994 be denied.

IT IS FURTHER ORDERED that this is a Final Order and is effective upon service upon the parties. Any party may, within fifteen (15) days after service, file a Petition for Reconsideration. The filing of a Petition for Reconsideration is not a prerequisite for seeking administrative or judicial review.
