NOW on this th 9 day of March, 2010, this matter comes before Kathleen Selzler Lippert, Acting Executive Director, Kansas State Board of Healing Arts (“Board”), concerning Licensee’s satisfaction of all requirements contained in the Consent Order Licensee entered into with the Board which was filed on September 9, 2009. Wherefore, the Board finds as follows:

1. On or about September 9, 2009, Licensee entered into a Consent Order with the Board to address concerns about timely completion of medical records. The Consent Order contained a provision for Licensee to complete Board approved ethics course; a medical record keeping course and a fine of \$1000 all due on or before March 1, 2010.
2. Licensee provided proof of a Board approved record keeping course on November 12, 2009.
3. Licensee provided proof of a Board approved ethics course on March 3, 2010, completion of this course was on February 18, 2010.
4. Licensee paid the \$1000 fine on or about November 23, 2009.
5. Licensee has satisfied all requirements of the Consent Order and has no further obligation for compliance.

IT IS THEREFORE ORDERED that Licensee is hereby discharged from the requirements of the Consent Order filed on September 9, 2009.


