FINAL ORDER

NOW ON THIS Eleventh Day of December 2004, this matter comes on for review of the Initial Order issued by Ms. Betty McBride, Presiding Officer. Licensee appears in person and through Brian C. Wright. Kelli J. Benintendi, Associate Counsel, appears for the Board.

Having the agency record before it, the Board finds, concludes and orders as follows:

1. This matter was initiated with a request from Licensee to modify the limitations upon his license. Those limitations were imposed by a consent order dated September 24, 2003.
2. The parties to the proceeding submitted an agreed-upon order to the Presiding Officer. The Presiding Officer adopted the agreed-upon order as the Initial Order.
3. The Board adopts the findings, conclusions and order stated in the Initial Order as the findings, conclusions and order of the Board.

IT IS, THEREFORE, ORDERED that the Licensee's request to modify the prior consent order is granted. The limitation on Licensee's license prohibiting him from prescribing or ordering any controlled substance unless it is administered in a hospital as

part of Licensee's practice with Anesthesia Consulting Services, P.A. is hereby terminated.

PLEASE TAKE FURTHER NOTICE that this is a final order. A final order is effective upon service. A party to an agency proceeding may seek judicial review of a final order by filing a petition in the District Court as authorized by K.S.A. 77-601, et seq. Reconsideration of a final order is not a prerequisite to judicial review. A petition for judicial review is not timely unless filed within 30 days following service of the final order. A copy of any petition for judicial review must be served upon the Board's Executive Director at 235 SW. Topeka Blvd., Topeka, KS 66603.
