FINAL ORDER FOLLOWING CONFERENCE HEARING

NOW, on this 21st day of June, 2008, comes on for conference hearing before the Kansas State Board of Healing (“Board”) the letter request to terminate Board Consent Order filed by Edward Wade, M.D. (“Licensee”). Licensee appears in person *pro se*. Kelli Stevens, Litigation Counsel, appears for the Board.

After reviewing the file, hearing the statements of the parties, and being duly advised in the premises, the Board finds, concludes and orders as follows:


1. Licensee agreed to a Consent Order for Status Change that was approved by the Board and was filed September 24, 2003..
2. In the Consent Order, Licensee agreed to certain limitations regarding his license to practice medicine and surgery.
3. The Consent Order was subsequently modified by a Final Order filed December 14, 2004 and a Final Order filed June 29, 2005.
4. Licensee has been in compliance with the Consent Order for Status Change as modified.
5. The Consent Order for Status Change and the provisions and limitations imposed upon Licensee and his license to practice medicine and surgery by such Consent Order should be terminated.

IT IS THEREFORE ORDERED that Licensee's request to terminate Consent Order for Status Change should be granted and the Consent Order for Status Change should have no further force or effect.

PLEASE TAKE NOTICE that this is a Final Order. A Final Order is effective upon service. A party to an agency proceeding may seek judicial review of a Final Order by filing a petition in District Court as authorized under the Kansas Act for Judicial Review and Civil Enforcement of Agency Actions, K.S.A. 77-601 *et seq.* A petition for judicial review is not timely unless filed within 30 days following service of the Final Order. A copy of any such petition must be served upon the Board addressed to the Executive Director, 235 S. Topeka Boulevard, Topeka, Kansas 66603. A request for reconsideration is not a prerequisite to judicial review.


