A G R E E M E N T

KANSAS STATE BOARD OF  
HEALING ARTS

THIS AGREEMENT made and entered into this 9th day of February, 1991, by and between THE KANSAS STATE BOARD OF HEALING ARTS (hereafter "Board") and PAUL E. WAKIM, D.O. (hereafter "Licensee").

WITNESSETH:

WHEREAS, Licensee was originally issued License No. 15334 on June 15, 1973 to practice osteopathic medicine and surgery in the State of Kansas; and

WHEREAS, the Board has terminated a Stipulation dated May 31, 1987 between Board and Licensee and dissolved an Enforcement Order dated June 13, 1987 issued pursuant thereto which had required Licensee, in lieu of the Board's further investigation, reviews or disciplinary proceedings, to give the Board at least 90 days notice prior to actively engaging in the practice of osteopathic medicine and surgery in the State of Kansas; and

WHEREAS, Licensee's license to practice in the State of Kansas was cancelled at Licensee's request on August 23, 1985 and has not since that time been renewed or reinstated; and

WHEREAS, as a result of the cancellation of Licensee's license, it will be necessary for Licensee to reinstate the license pursuant to the statutes and rules and regulations which are in effect at such time as Licensee may seek reinstatement in order to again actively engage in practice in the State of Kansas.

NOW, THEREFORE, in consideration of the mutual covenence, promises and agreements contained herein, the parties hereto agree as follows:

1. The aforementioned Stipulation and resulting Enforcement Order did not reflect disciplinary action arising from any findings of fact or conclusions of law which were made following the conclusion of any formal proceedings and did not evidence any finding by the Board that Licensee had violated the Healing Arts Acts or any provisions thereof.

2. The Board shall report the status of Licensee's license to third parties so as to convey that Licensee's license to practice osteopathic medicine and surgery in the State of Kansas was cancelled August 23, 1985 at Licensee's request and that, since the date of the termination of the aforementioned Stipulation and dissolution of the resulting Enforcement Order, the license is not otherwise under any restrictions or limitations.

3. Licensee agrees that the Board shall upon the filing by Licensee of an Application For Reinstatement of License to practice osteopathic medicine and surgery in the State of Kansas, have the right to conduct a full background investigation of Licensee to the extent it deems necessary regarding any of his past, present or future professional conduct and fitness to practice osteopathic medicine and surgery in the State of Kansas.

4. Licensee further waives any and all affirmative defenses he might assert for any acts done by Licensee prior to the date of this Agreement including, but not limited to, laches, statute of limitations, waiver, estoppel and res judicata, and agrees that any

such acts may be considered by the Board and serve as a basis for the Board's action on any Application For Reinstatement of License which Licensee may hereafter file.

IN WITNESS WHEREOF, the parties hereto have executed this Agreement on the date indicated below their signature, it being specifically and expressly understood that this Agreement shall not become effective until such time as it has been signed by both parties hereto.
