ORDER GRANTING SECOND TEMPORARY REGISTRATION

NOW on this 12th day of February, 2000, this matter comes on for conference proceedings before the full Board at the request of Eliska C. Webster ("Applicant") to grant a second temporary registration pursuant to K.S.A. 65-2896(d). Applicant appears in person.

After reviewing the file, hearing statements from the Applicant, and upon receiving information from Charlene Abbott, Licensing Administrator, the Board finds:

1. A first temporary registration was issued to Ms. Webster on September 27, 1999 and expires on February 28, 2000.
2. Applicant did not pass the NCCPA examination in October, 1999, and is requesting a second temporary registration so that she may continue working until she has an opportunity to re-take the examination.
3. Pursuant to 65-2896(d), not more than one temporary registration shall be permitted to any one person without the majority approval of the member of the Board.
4. The Board finds sufficient cause exists to grant Applicant a second temporary registration.
5. Upon payment of the appropriate fees, Applicant should be granted a second temporary registration to expire August 12, 2000.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED as follows:

- A. That upon payment of the appropriate fee, a second temporary registration be granted to Applicant to expire August 12, 2000.
- B. That this is a Final Order and is effective upon service upon the parties. Any party

may, within fifteen (15) days after service, file a Petition for Reconsideration. The filing of a Petition for Reconsideration is not a prerequisite for seeking administrative or judicial review.
