ORDER OF RETROACTIVE MODIFICATION TO LICENSE STATUS

NOW, on this 12th day of June, 1993, comes on for consideration before the Kansas State Board of Healing Arts, sitting as a whole as Presiding Officer in a summary proceeding pursuant to the provisions of K.S.A. 1992 Supp. 77-538, the request of Hugh A. Wiegman, M.D. (hereafter "Licensee") for retroactive modification of license status. Licensee did not appear.

After reviewing the request and being otherwise duly advised in the premises, the following findings are made:

- 1. Licensee was originally licensed to practice medicine and surgery in the state of Kansas on June 8, 1968.
- 2. On June 14, 1990, Licensee applied to have the status of his license changed from active to exempt and said status was so changed effective June 15, 1990.
- 3. That by inadvertence Licensee failed to indicate that he did not desire the exempt license to commence until July 1, 1990.

- 4. Licensee's professional liability insurance coverage continued in effect through June 30, 1990 and Licensee continued to practice through June 30, 1990.
- 5. On April 5, 1991, Licensee filed an application to change his exempt status to active and such status change was made effective that date.
- 6. Licensee had professional liability insurance and was current with his continuing education as of April 1, 1991 and it was only due to inadvertence and mistake that he failed to submit an application for status change to active until april 5, 1991.

IT IS THEREFORE BY THE BOARD ORDERED AS FOLLOWS:

- A. That the findings here and above made be and the same are made the order of the Board.
- B. The status of the license of the Licensee, Hugh A. Wiegman, M.D., to practice medicine and surgery in the state of Kansas should be retroactively modified to reflect that Licensee has held an active license for the period of June 15, 1990 through June 30, 1990.
- C. That status of Licensee's license should be further retroactively modified to reflect that Licensee has held an active license from and since April 1, 1991.
- D. Licensee is entitled to an administrative review of this Order of Retroactive Modification to License Status if a written request is received in the Board office within 15 days of the date of service of this Order upon Licensee.

IT IS SO ORDERED.
