NOTICE OF RETROACTIVE REINSTATEMENT OF LICENSE

NOW, on this 5th day of February, 1994, this matter comes on for consideration before the Kansas State Board of Healing Arts (hereafter "Board"), sitting as a whole as Presiding Officer in a conference proceeding pursuant to the provisions of K.S.A. 77-533, the request of Charles L. Weinstein, M.D. (hereafter "Licensee") for retroactive reinstatement of license. Licensee did not appear.

After reviewing the request and being otherwise duly advised in the premises, the Board finds as follows:

1) On June 16, 1992, Licensee renewed his license which was originally issued on July 1, 1972, pursuant to K.S.A. 65-2809(a).

2) Said license was cancelled for non-renewal on August 23, 1993.

3) Pursuant to Board records, Licensee applied for reinstatement on September 17, 1993.

4) The Application for Reinstatement was deemed complete on October 26, 1993 and the license of Licensee was reinstated effective that date.

5) From August 23, 1993, until October 26, 1993, Licensee maintained professional liability insurance in compliance with Kansas law and had the required continuing education necessary to qualify for reinstatement.

6) By letter received December 22, 1993, Licensee requested that the Board retroactively reinstate his license to practice medicine and surgery to August 23, 1993.

7) The failure of Licensee to renew his license and the cancellation of such license on August 23, 1993 was due to the inadvertency and mistake of Licensee.

IT IS THEREFORE BY THE BOARD ORDERED as follows:

A. That the findings here and above made be and the same are made the Order of the Board.

B. That license number 4-15070 issued to Charles L. Weinstein, M.D., cancelled on August 23, 1993 and reinstated on October 26, 1993, be retroactively reinstated to August 23, 1993 to reflect that Licensee has continuously held a current license from and since August 23, 1993.

C. That as a condition of the aforementioned retroactive reinstatement of license, an administrative fine in the amount of two hundred dollars (\$200) be assessed to Licensee for his inadvertence and mistake in allowing his license to be cancelled for nonrenewal on August 23, 1993. Payment of said fine to be received in the board office within thirty (30) days of service of this Order.

D. This is a Final Order and is effective upon service upon the parties. Any party may, within fifteen (15) days after service, file a Petition for Reconsideration. The filing of a Petition for Reconsideration is not a prerequisite for seeking administrative or judicial review.

IT IS SO ORDERED.
