## ORDER DISMISSING EMERGENCY PETITION

NOW, on this 14th day of May, 1993, this Emergency Petition matter comes on before a Hearing Panel of the Kansas State Board of Healing Arts (hereinafter "Board"). Present are Rex A. Wright, D.C., President, and Donald Bletz, M.D., Vice-President.

The Board appears by Kevin LaChance, Board Counsel. Kristopher K. Wendler, M.D., (hereinafter "Licensee") appears in person and with his legal counsel, Michael P. O'Keefe. This matter comes before the Hearing Panel pursuant to K.S.A. 77-512 and K.S.A 77-536 and is conducted in accordance with the Kansas Administrative Procedures Act (K.S.A. 77-501 et seq.).

After hearing the evidence and reviewing the proposed restrictions as stated in Licensee's letter of May 12, 1993, the hearing panel finds the following:

That Licensee has voluntarily agreed to provide specific safeguards as stated in the record and agrees to enter into a written Stipulation and Agreement and Enforcement Order

incorporating the restrictions stated in his letter of May 12, 1993, with several modifications made by the Hearing Panel.

That based on Licensee's agreement to enter into a Stipulation and Agreement and Enforcement Order, there is no immediate or imminent danger to the public health, safety or welfare as the restrictions sufficiently protect the public. Therefore, the Emergency Petition is denied and dismissed.
