**ORDER DENYING RECONSIDERATION AND

NOW ON THIS 17th Day of February, 1996, comes on for hearing Respondent's Petition for Reconsideration and Application for Stay of the Final Order filed January 26, 1996. Respondent appears in person and through Kenneth J. Reilly, Attorney at Law. The Board appears through Kevin K. LaChance, Disciplinary Counsel.

After hearing the arguments of counsel and statement of Respondent, and having the agency record before it, and with Dr. John P. Gravino, D.O. and Dr. Howard D. Ellis, M.D. recused, the Board denies reconsideration at this time, and will take no further action until an Initial Order is issued in case no. 93-00140, now pending against Respondent.

The application for stay of the final order is denied. Counsel for the parties are encouraged to confer and determine whether a less restrictive order can be agreed upon pending resolution of case no. 93-00140.

Finally, the parties are urged to complete the pending proceeding in case no. 93-00140. At the conclusion of that case, and either upon request of a party or upon the Board's own motion, the Board may reconsider what disciplinary action is appropriate in light of the findings in case no. 93-00140 and this case.


