ORDER DENYING MODIFICATION OF  
STIPULATION AND AGREEMENT

NOW on this 12th day of June, 1992, this matter comes before the Kansas State Board of Healing Arts on request from Kermit E. White to modify the April 15, 1992 Stipulation and Agreement and Enforcement Order.

Licensee, Kermit E. White, M.D. does not appear nor does anybody appear on behalf of Dr. White. Board appears by and through Steve A. Schwarm, Board General Counsel.

The Board takes administrative notice that by letter dated May 18, 1992, Dr. White, by certified mail, requested consideration by the Board of a monthly payment schedule of \$250 per month for a period of 30 months.

The Board specifically notes that on March 29, 1992, Kermit E. White, M.D. affixed his signature to a Stipulation and Agreement which became an Order of the Board April 15, 1992. Under paragraph 7(d)(i) of the Stipulation and Agreement and Enforcement Order it specifically states that as an appropriate disciplinary sanction, the Board hereby assesses a civil fine in the amount of

\$7,500 against Applicant Kermit E. White, M.D. Furthermore, the Board notes that under paragraph 7(e) it is stated that if Applicant fails to fulfill any of the obligations under the Stipulation and Agreement, the Board will be released from its Stipulation and Agreement and subsequent Enforcement Order and shall be free to take whatever steps it deems appropriate to include exercise of its right to issue a Summary Revocation Order as set forth below.

The Board specifically notes that Licensee Kermit E. White, M.D. has not entered into an acceptable post-graduate training program, residency program or any other type of program or practice under the jurisdiction of the Kansas State Board of Healing Arts. Therefore, a Summary Revocation Order will not be issued. However, the Board notes the failure to remit \$7,500 as an administrative fine as set forth in the Enforcement Order of April 15, 1992 as a condition to granting any license status to Dr. White results in the license of Dr. White remaining cancelled until such time as Dr. White remits the \$7,500 administrative fine in total and meets all other conditions and provisions set forth in the April 15, 1992 Stipulation and Agreement and Enforcement Order.

IT IS THEREFORE ORDERED, DECREED AND ADJUDGED that the Request for Modification of Stipulation, Agreement and Enforcement Order filed April 15, 1992 to permit payment of \$7,500 through appropriate payment schedule is specifically and hereby denied.

Pursuant to K.S.A. 77-537, this decision, which is called a Summary Order is subject to your request for a hearing. If you desire a hearing before the Kansas State Board of Healing Arts to contest the content of this Order, you must file a written request for such a hearing and direct it to the following:


