ORDER OF CANCELLATION OF LICENSE

NOW, on this 31st day of July, 1990, this matter comes before Richard G. Gannon, Executive Director of the Kansas State Board of Healing Arts (heareafter "Board") serving as Presiding Officer in summary proceedings.

The Presiding Officer specifies the following findings of fact, conclusions of law and reasons for actions:

1. Licensee's license issued by the Board to practice in the State of Kansas expired June 30, 1990 pursuant to K.S.A. 1989 Supp. 65-2809(a).
2. In compliance with K.S.A. 1989 Supp. 65-2809(d), Licensee was notified by the Board on or about May 9, 1990 of the expiration of Licensee's license by mail directed to the last address on file at the Board office.
3. In further compliance with K.S.A. 1989 Supp. 65-2809(d), a second notice, following the expiration of Licensee's license was mailed to Licensee on or about July 13, 1990.
4. Licensee has not requested renewal of Licensee's license in accordance with K.S.A. 189 Supp. 65-2809 and the rules and regulations of the Board.
5. Due to Licensee's failure to renew, the license issued by the Board to Licensee to practice in the State of Kansas should be cancelled.


