**JOURNAL ENTRY OF SATISFACTION

NOW, on this 12<sup>th</sup> day of April 2010, this matter comes before Kathleen Selzler Lippert, Acting Executive Director, Kansas State Board of Healing Arts ("Board"), concerning Licensee's satisfaction of all requirements contained in the Final Order which was filed on December 09, 2009. Wherefore, the Board finds as follows:

1. On or about December 4, 2009, the Board issued a Final Order regarding the license of Angela Renee Wiesner, L.R.T. ("Licensee") to practice as a radiologic technologist in the state of Kansas. The Final Order contained a provision for Licensee to pay a fine in the amount of \$250. The Licensee had requested a payment plan which was approved.
2. Licensee paid \$50 toward the \$250 fine on February 3, 2010.
3. Licensee paid \$50 toward the \$250 fine on March 2, 2010.
4. Licensee paid \$150 toward the \$250 fine on April 7, 2010.
5. On or about December 4, 2009, the Board issued a Final Order regarding the license of Angela Renee Wiesner, L.R.T. ("Licensee") to practice as a radiologic technologist in the state of Kansas. The Final Order contained a provision for Licensee to submit proof of 12 hours of continuing education or a current copy of her American Registry of Radiologic Technologist (ARRT) card on or before February 27, 2010.

6. Licensee submitted a copy her ARRT card on December 15, 2009
7. Licensee has satisfied all requirements of the Final Order and has no further obligation for compliance.

**ITS IS THEREFORE ORDERED** that Licensee is hereby discharged from the requirements of the Final Order filed on December 9, 2009.
