COMES NOW the Kansas State Board of Healing Arts (“Board”), by and through its Executive Director, Kathleen Selzler Lippert, a duly authorized representative of the Board, in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501 *et seq.*, as amended, and upon due consideration of the agency record and applicable statutes and regulations, and being otherwise duly advised in the premises, makes the following determinations:

1. On or about July 9, 2014, in accordance with K.S.A. 2011 Supp. 77-537 and 77-514, and as authorized by K.S.A. 65-2910(c), a Summary Order was issued ordering that the license of DeAnna Wiggett, P.T.A. (“Licensee”) to practice as a physical therapy assistant in the State of Kansas be Cancelled for Failure to Renew failing to remit the renewal fee as required for renewal of her license.
2. Pursuant to K.S.A. 77-542, the Summary Order notified Licensee that if a written request for hearing was not filed within 15 days following service of the Summary Order, the Summary Order would become effective as a Final Order of the Board upon expiration of the time for requesting a hearing.
3. Licensee did not request a hearing on the Summary Order.


4. On or about July 22, 2014, Licensee remitted full payment of her required licensing fee in the amount of \$105.00 to the Kansas State Board of Healing Arts.

5. Licensee has satisfactorily met all requirements of the Summary Order and has no further obligation for compliance.
