FINAL ORDER

NOW on this 3rd day of June, 1994, comes on for consideration before the Kansas State Board of Healing Arts ("Board") sitting as a whole as Presiding Officer in a conference proceeding pursuant to the provisions of K.S.A. 77-533 through 77-535, the application of Gail R. Williams, M.D. ("Applicant") for licensure by endorsement to practice medicine and surgery in the State of Kansas. Gretchen E. Schmidt, Associate Counsel, appears for and on behalf of the Board. Applicant appears pro se.

After reviewing the application and being otherwise duly advised in the premises, the Board finds as follows:

FINDINGS OF FACT

1. On January 13, 1994, Applicant filed an application for endorsement to obtain a license to practice medicine and surgery in the State of Kansas.
2. Based upon information provided by Applicant in his application, the Board conducted an investigation into Applicant's affirmative answers to questions 3, 8, 9, 10, 11, 16, and 18 of section VI of the application.
3. On June 19, 1985, the State of Michigan Board of Medicine revoked Applicant's Michigan medical license. Said revocation was based upon Applicant's sexual relationship with

a female patient from late 1981 to mid-1983 and his sexual activity with such patient during bi-weekly counselling therapy sessions. Applicant's behavior was described as a pattern of conduct resulting in the continued and repeated sexual exploitation of the patient by Applicant under the guise of medical treatment. Applicant was further found to have engaged in unethical business practice by obtaining third party insurance reimbursement by fraud or deceit.

4. Applicant was denied reinstatement by the State of Michigan on April 15, 1987, January 3, 1989, and September 19, 1990.

5. On December 3, 1993, a Final Order of Revocation of License was issued by the Oklahoma State Board of Medical Licensure and Supervision on the basis Applicant, in the course of his practice of medicine, sexually battered and harassed female professional staff and support staff members at his place of employment.

CONCLUSIONS OF LAW

1. Applicant has had a license to practice the healing arts revoked by the proper licensing authority of another state, specifically the States of Michigan and Oklahoma, in violation of K.S.A. 65-2836(j).

2. Applicant has committed an act of unprofessional or dishonorable conduct or professional incompetency in violation of K.S.A. 65-2836(b). "Unprofessional conduct" is defined by K.S.A. 65-2837(b)(16) as any act of sexual abuse, misconduct or exploitation related to the licensee's professional practice.

3. The above-noted facts and conclusions constitute grounds for which the Board may deny an application for licensure by endorsement to practice medicine and surgery in the State

of Kansas.

IT IS THEREFORE BY THE BOARD ORDERED as follows:

(A) That the findings herein above made be in the same are made the Order of the Board.

(B) Adequate information has been provided to the Board to justify denial of a permanent license to Applicant to practice medicine and surgery in the State of Kansas. Applicant's application for licensure by endorsement is therefore **DENIED**.

(C) This is a Final Order and is effective upon service upon the parties. Any party may, within 15 days after service, file a Petition for Reconsideration. The filing of a Petition for Reconsideration is not a prerequisite for seeking administrative or judicial review.

IT IS SO ORDERED.
