**FINAL ORDER FOLLOWING CONFERENCE HEARING**

NOW, on this 18th day of October 1997, comes on before the Kansas Board of Healing Arts ("Board") the request of Wayne W. Williamson, D.O. ("Licensee") that the **Stipulation and Agreement and Order** ("Stipulation") filed on October 29, 1996, be terminated. Kevin K. LaChance appeared for the Board. There were no other appearances.

After examining the files, hearing statements of counsel and being otherwise duly advised in the premises, the Board finds as follows:

1) The Stipulation was entered into between Licensee and the Board on October 29, 1996.

2) That after hearing statements of counsel and based on information presented, the Board is not satisfied that Licensee has been totally forthcoming with

federal and state regulatory agencies regarding the limitations placed upon his license by the Stipulation. Specifically, Licensee has engaged in conduct that, had it not been curtailed by cooperative efforts between the state and federal agencies, may have resulted in a violation of the terms of the Stipulation. Additionally, the Stipulation states in paragraph 10 that the Stipulation is in effect for a period of at least 2 years from the date that a Board authorized signature is place on the Stipulation. In that 2 years have not passed since this Stipulation was filed, Licensee's application for termination should be denied as untimely requested.

3) The Stipulation remains in full force and effect.

**NOW, THEREFORE**, it is ordered by the Board that the findings hereinabove made be and the same are hereby made the order of the Board; that Licensee's request for termination of the **Stipulation and Agreement and Order** is hereby **DENIED**.

**IT IS SO ORDERED.**
