**FINAL ORDER TERMINATING MONITORING**

NOW on this 22<sup>nd</sup> day of June 2012, comes before the Kansas State Board of Healing Arts (“Board”) the request of Christopher E. Wilson, M.D. (“Licensee”) for termination of monitoring. Licensee appears in person and by and through counsel, Carol Ruth Bonebrake of Holbrook & Osborn, P.A.. Reese H. Hays, Litigation Counsel, appears on behalf of the Board.

Pursuant to the authority granted to the Board by the Kansas Healing Arts Act, K.S.A. 65-2801 *et seq.* and in accordance with the provisions of the Kansas Administrative Procedure Act K.S.A. 77-501 *et seq.*, the Board hereby enters this Final Order in the above-captioned matter. After reviewing the file, hearing the statements and arguments of the parties, hearing the testimony of Licensee and being otherwise duly advised in the premises, the Board makes the following findings, conclusions and orders:

1. Christopher E. Wilson, M.D. (“Licensee”), is licensed to engage in the practice of medicine and surgery in the State of Kansas, License No. 04-29947, and has been so licensed since approximately December 14, 2002.
2. On or about February 11, 2006, the Board filed a Motion for *Ex Parte* Emergency Suspension of Licensee’s license.
3. On or about February 13, 2006, an Emergency Order suspending Licensee’s license was filed with the Board. According to the Emergency Order, Licensee was found to be

unsafe to practice the Healing Arts with reasonable skill and safety      CONFIDENTIAL

4.      On August 12, 2006, Licensee entered into a Consent Order with the Board to resolve allegations      CONFIDENTIAL

5.      The Consent Order provided that the suspension of Licensee's license be terminated      CONFIDENTIAL

At the end of five years,

Licensee may petition the Board for termination of the Consent Order requirements.

8.      On or about May 12, 2012, Licensee submitted a request to the Board for termination of the monitoring requirements imposed upon Licensee by the Consent Order.


9.      On May 23, 2012, the Respondent Board filed a Response to Licensee's Motion.

10.     Upon review of the evidence presented, the Board determined that Licensee has satisfactorily met all monitoring requirements of the Consent Order sufficient to warrant termination, and has no further obligation for compliance.

**IT IS THEREFORE ORDERED, BY THE KANSAS STATE BOARD OF HEALING ARTS,** that Licensee has satisfied all terms and conditions of the Consent Order and

that Licensee's request to terminate the monitoring requirements imposed by the Consent Order is hereby granted.

Pursuant to K.S.A. 77-529, Licensee may petition the Board for Reconsideration of a Final Order within fifteen (15) days following service of the final order. Additionally, a party to an agency proceeding may seek judicial review of a Final Order by filing a petition in the District Court, as authorized by K.S.A. 77-601, *et seq.* Reconsideration of a Final Order is not a prerequisite to judicial review. A petition for judicial review is not timely unless filed within **30 days** following service of the Final Order. 
