## JOURNAL ENTRY ON MODIFICATION OF CONSENT ORDER

On August 10, 2018, the parties appeared before the Board for a conference hearing. Michael Craig Wilson, D.C. ("Licensee") appeared in person and by counsel, Megan Moseley. Deputy Litigation Counsel Susan Gering also appeared. The parties submitted a proposed Consent Order, executed by Applicant on June 25, 2018, for the Board's review and approval. The Board heard statements both counsels and testimony from Licensee. Upon review of the proposed consent order, and taking into consideration of the statements and testimony received at the hearing, the Board determined that subpart "a." of paragraph 59 of the consent order should be revised. This revision was discussed with the parties at the hearing and the Licensee agreed to the revision.

Therefore, the Board **ORDERS** that the consent order that was executed by Licensee on June 25, 2018, submitted to the Board for review and approval at the August 10, 2018 Board meeting, and subsequently signed by the Executive Director and filed in this matter, is hereby modified to delete and vacate subpart "a." of paragraph 59. The following is added to paragraph 59 by interlineation expressed in this Journal Entry:

"a. Licensee will submit a complete list of all patients included on his patient schedule to T.O.P. Education LLC on the 28<sup>th</sup> of each month. Out of the patients on this list, T.O.P. Education LLC shall randomly select 10 patient charts to review Licensee's documentation and billing. Licensee shall promptly provide the selected 10 original and unaltered patient charts to T.O.P. Education LLC to review."

The remainder of the consent order remains in effect. This Journal Entry is entered on the 23rd day of August 2018.
