**FINAL ORDER FOLLOWING REVIEW OF INITIAL ORDER**

NOW ON THIS Twenty-fifth day of April, 1998, this matter comes before the Kansas State Board of Healing Arts for review of the Initial Order. Kevin K. LaChance, Disciplinary Counsel, appeared on behalf of the Board. There were no other appearances.

Having the agency record before it, and after hearing statements counsel, the Board adopts as its Final Order the findings of fact and conclusions of law as stated in the Initial Order. The Board further concludes that disciplinary action based upon the findings rests within the Board's sound discretion. Upon motion duly made, seconded and passed by a majority of members then present, the Board determines that the portion of the Initial Order imposing a three-year suspension of Respondent's license should be modified, and that Respondent's license should be revoked.

**IT IS THEREFORE ORDERED AS FOLLOWS:**


1. The findings of fact and conclusions of law appearing in the Initial Order are hereby adopted as the findings and conclusions of the Board.
2. The Licensee's license is hereby revoked.
3. An administrative fine of \$5400 and costs of the proceeding will be assessed

against the Licensee. Disciplinary Counsel will submit an itemization of costs to be assessed at the June 13, 1998 Board Meeting.

4. The Emergency Suspension shall be extended until the Revocation takes place.
