FINAL ORDER

NOW ON THIS 10th day of June, 2010, the above-entitled matter comes on before Kathleen Selzler Lippert, Executive Director of the Kansas State Board of Healing Arts. After reviewing the file and being duly advised in the premises, the Executive Director makes the following determinations.

1. On May 13, 2010, the Executive Director issued a Summary Order regarding the license of Michael A. Wilson, M.D. (“Licensee”) to practice medicine and surgery in the State of Kansas. The Summary Order contained a provision suspending Licensee’s license until such time as the Board received information from CPEP that Licensee’s educational plan was reinstated and that upon reinstatement of the CPEP educational plan, Licensee’s license would be placed on probation until such time as Licensee successfully completes said CPEP educational plan.

2. The Summary Order contained a notice that a written request for hearing could be filed within 15 days following service, but if no hearing is requested, the Summary Order would become effective as a final order of the Board upon expiration of the time for requesting a hearing.

3. No hearing has been requested by any party.

4. On May 18, 2010, the Board was notified by Mary Minobe, Program Coordinator,

Educational Services, CPEP, that Licensee had submitted all required materials and fees and that as of that date his educational plan was reinstated.

5. As Licensee's educational plan has been reinstated, Licensee's license was not subject to suspension but is placed on probation until such time as Licensee successfully completes said CPEP educational plan as per the Summary Order filed on May 13, 2010.

6. Therefore the Summary Order became effective as a Final Order on June 1, 2010.
