FINAL ORDER

NOW, on this 12th day of June, 2009, the above-entitled matter comes on before the Kansas State Board of Healing Arts (“Board”) for conference hearing on Licensee’s request for Restoration of License without Restrictions or Modifications. Licensee appears with counsel, Michael Francis of Topeka, KS. Kelli Stevens, Associate Litigation Counsel, appears for the Board. There are no other appearances.

WHEREUPON, having the agency record before it, hearing the testimony of Licensee, hearing the statements and arguments of counsel and being duly advised in the premises, the Board FINDS and ORDERS as follows:

1. In July of 2003, by Final Order Licensee was granted active status subject to limitations on his scope of practice and monitoring provisions.
2. In December of 2005 a request by Licensee to modify or terminate supervision requirements on his license was denied.
3. The Board finds that Licensee has substantially complied with the limitations on his scope of practice and monitoring provisions.
4. Continued monitoring of Licensee is not necessary.
5. Licensee is hereby granted an unrestricted license.


PLEASE TAKE FURTHER NOTICE that this is a final order. A final order is effective upon service. A party to an agency proceeding may seek judicial review of a final
