## FINAL ORDER FOLLOWING CONFERENCE HEARING

NOW, on this 2nd day of December, 2006, comes on for conference hearing before the Kansas State Board of Healing Arts ("Board") the request for retroactive reinstatement of license filed by Deborah Woosley-Davis, M.D. ("Licensee"). Charlene K. Abbott, Licensing Administrator provided information to the Board. Applicant appeared in person *pro se*.

After reviewing the file, hearing the information provided by Ms. Abbott, hearing the testimony of Licensee and being otherwise duly advised in the premises, the Board makes the following findings and orders:

- 1. Licensee was originally issued license number 04-30491 to practice medicine and surgery in the state of Kansas on August 14, 1999.
- Licensee's license expired June 30, 2006 and was canceled effective August 1,
   2006 for failure to renew for the period July 1, 2006 through June 30, 2007.
- 3. On August 8, 2006, Licensee filed an Application for Reinstatement which was determined to be complete and her license to practice medicine and surgery was reinstated effective August 9, 2006.

- 4. By letter dated August 8, 2006, which accompanied Licensee's Application for Reinstatement, Licensee requested retroactive reinstatement of her license back to August 1, 2006.
- 5. During the period August 1, 2006 to September 5, 2006, Licensee engaged in the practice of medicine and surgery in the state of Kansas, maintained a policy of professional liability insurance in compliance with Kansas law and paid the required surcharge to the Health Care Stabilization Fund.
- 6. It was due solely to inadvertence, mistake or neglect that Licensee practiced while her license was canceled from August 1, 2006 until August 9, 2006.
- 7. The status of Licensee's license should be modified and retroactively reinstated on active status for the period August 1, 2006 to August 9, 2006.
- 8. For her inadvertence, mistake or neglect for practicing medicine and surgery in the state of Kansas after her license was canceled, Licensee should be assessed a civil fine in the amount of \$350, to be payable within 30 days of the effective date of this order.
- IT IS THEREFORE ORDERED that license number 04-28412 should be retroactively reinstated for the period August 1, 2006 until August 9, 2006, be considered to have been continuously on active status during such period of time, and the records of the Board be modified to reflect such retroactive reinstatement.
- IT IS FURTHER ORDERED that Licensee be assessed a civil fine in the amount of \$350, payable within 30 days of the effective date of this order, for her practice of medicine and surgery in the state of Kansas while her license was canceled.

PLEASE TAKE NOTICE that this is a Final Order. A Final Order is effective upon service. A party to an agency proceeding may seek judicial review of a Final Order by filing a petition in District Court as authorized under the Kansas Act for Judicial Review and Civil Enforcement of Agency Actions, K.S.A. 77-601 *et seq*. A petition for judicial review is not timely unless filed within 30 days following service of the Final Order. A copy of any such petition must be served upon the Board addressed to the Executive Director, 235 S. Topeka Boulevard, Topeka, Kansas 66603. A request for reconsideration is not a prerequisite to judicial review.
