**ORDER GRANTING RETROACTIVE ISSUANCE
OF POSTGRADUATE PERMIT**

NOW ON THIS 28TH of April, 2001, comes on for consideration before the Kansas State Board of Healing Arts (hereafter "Board"), sitting as a whole as Presiding Officer in a Conference Proceeding pursuant to the provisions of K.S.A. 77-533, the request of John C. Wu, M.D. (hereafter "Petitioner") for retroactive issuance of postgraduate permit.

Charlene Abbott, Licensing Administrator, presents information to the Board. Petitioner appears in person.

After hearing statements of the parties and being duly advised in the premises, the Board finds as follows:

1. Petitioner completed an application for a postgraduate permit for the Department of Surgery at Kansas University Medical Center indicating the program would begin June, 1996 and be completed June 30, 2001.
2. Petitioner was issued postgraduate permit number 94-04503, effective May 24, 1996 to expire June 23, 1999. At the time permit was issued, Kansas law provided that postgraduate permits not exceed three years.
3. On July 15, 1999 the Board sent a notice to Petitioner at the Department of

Surgery at Kansas University Medical Center that the permit was scheduled to be canceled due to its expiration. Notice was mailed to Petitioner at the University of Kansas Medical Center, the address which Petitioner requested mail be sent.

The Department of Surgery did not contact the Board regarding the cancellation.

4. Petitioner was unaware of the expiration of permit or the notice of cancellation.
5. On March 9, 2001 the University of Kansas suspended Petitioner's residency training for lack of permit to practice.
6. Executive Director of the Board, Lawrence Buening, approved a second postgraduate permit to be effective March 13, 2001 with an expiration of June 30, 2001.
7. Petitioner requested by fax on March 13, 2001 that the second postgraduate permit be issued retroactively to be effective from June 23, 1999.
8. The Board finds sufficient cause exists to grant Petitioner retroactive issuance of a second postgraduate permit from June 23, 1999.

IT IS THEREFORE ORDERED AS FOLLOWS:

1. That the findings here and above made be and the same are made the order of the Board.
2. That the second postgraduate permit issued to John C. Wu, M.D. originally issued effective March 13, 2001, be made effective retroactively from and after June 23, 1999.

IT IS SO ORDERED.
