FINAL ORDER FOLLOWING CONFERENCE HEARING

NOW, on this 11th day of December, 1999, comes before the Kansas Board of Healing Arts, (hereafter "Board") the Request to Withdraw Application submitted by Robert Louis Yacoub, M.D. (hereafter "Applicant"). Lawrence T. Buening, Jr., Executive Director, presented information before the Board. There were no other appearances.

After reviewing the file and being duly advised in the premises, the Board finds as follows:

1. At the August 14, 1999 Board meeting, a summary hearing was conducted regarding Applicant's July 2, 1999 application for licensure by endorsement.
2. Applicant's application for endorsement established that Applicant received his Doctor of Medicine Degree in 1984 from the Universidad Tecnologica De Santiago (UTESA), located in Santo Domingo, Dominican Republic.
3. The Board was unable to determine that UTESA had standards similar to those in Kansas and by Summary Order filed on October 1, 1999, the Board denied Applicant's application by endorsement.
4. On October 12, 1999, by letter to Lawrence Buening, Jr, Executive Director, Applicant requested that he be allowed to withdraw his application for licensure.

5. Notice of a Conference Hearing on Applicant's application for licensure was set for 11:15 a.m., December 11, 1999 and filed herein on November 24, 1999 and served on Applicant.

6. At the Conference Hearing held on December 11, 1999, after reviewing the file, hearing statements from Mr. Buening and being otherwise duly advised in the premises, the Board finds that Applicant's Application for Licensure may be withdrawn.

IT IS THEREFORE ORDERED AS FOLLOWS:

Applicant's Application for Licensure in the state of Kansas be voluntarily withdrawn and no further proceedings are required or necessary.


