**FINAL ORDER LIFTING
LIMITATION OF LICENSE**

NOW, on the 7th day of December, 1996, comes on for hearing before the Kansas Board of Healing Arts ("Board") the request of German Zhitlovsky, M.D. (hereinafter "Licensee") that the **Final Order** of the Board filed on January 19, 1996, be lifted in its entirety. Lori McNett, Associate Counsel, appeared for the Board. Dr. Zhitlovsky appeared pro se.

After examining the files, hearing statements of counsel and being otherwise duly advised in the premises, the Board finds as follows:

- 1) A Final Order was entered by the Board on January 19, 1996.
- 2) By letter to the Board on October 30, 1996, Licensee requested that the limitations imposed upon his license be lifted.

3) Licensee's request was scheduled for Conference Hearing at 9:15 a.m. on December 7, 1996.

4) That after hearing statements of the parties, the Board is satisfied that Licensee has been in compliance with the conditions, restrictions and limitations placed upon Licensee's license.

NOW, THEREFORE, it is ordered by the Board that the findings hereinabove made be and the same are hereby made the order of the Board; that any and all limitations and restrictions imposed upon Licensee's license in the **Final Order**, filed on January 19, 1996, are hereby lifted and of no further force or effect.


