ORDER OF RETROACTIVE MODIFICATION TO LICENSE STATUS

NOW, on this 8th day of February, 1992, comes on for consideration before the Kansas State Board of Healing Arts (hereafter "Board") sitting as a whole as Presiding Officer in a summary proceeding pursuant to the provisions of K.S.A. 1991 Supp 77-538, the request of Marc S. Zipper, D.O., (hereafter "Licensee") for retroactive modification of license status. Licensee did not appear.

After reviewing the request and being otherwise duly advised in the premises, the Board finds as follows:

1. Licensee was originally licensed to practice medicine and surgery in the state of Kansas on June 16, 1989.
2. On August 14, 1990, Licensee applied for renewal of his license for the period ending June 30, 1991.
3. That on August 14, 1990, as part of his application for renewal of his license for the period July 1, 1990 through June 30, 1991, Licensee filed with the Board a Status Change Form on which he requested that his active license be changed to inactive

status and such request was processed by Board staff and the license status changed from active to inactive effective October 15, 1990, pursuant to an Agreed Order of Renewal.

4. That Licensee's license remained on inactive status from and since October 15, 1990 until July 30, 1991 when the license was renewed on active status for the period ending June 30, 1992.

5. That Licensee obtained professional liability insurance in compliance with Kansas law effective January 11, 1991 and was eligible to have his license placed on active status at that time but, due to misunderstanding or inadvertence, failed to do so.

IT IS THEREFORE BY THE BOARD ORDERED AS FOLLOWS:

A. That the findings here and above made be and the same are made the order of the Board.


B. The status of the license of the Licensee, Marc S. Zipper, D.O., to practice medicine and surgery in the state of Kansas should be retroactively modified to reflect that Licensee held an active license from January 11, 1991 to July 30, 1991 and will have active status continuously from January 11, 1991 until June 30, 1992 unless Licensee hereafter applies for a further status modification.

C. Licensee is entitled to an administrative review of this Order of Retroactive Modification to License Status if a written request is received in the Board office within 15 days of the date of service of this Order upon Licensee.

IT IS SO ORDERED.


