COMES NOW the Kansas State Board of Healing Arts (“Board”), by and through its Executive Director, Kathleen Selzler Lippert, a duly authorized representative of the Board, in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501 *et seq.*, as amended, and upon due consideration of the agency record and applicable statutes and regulations, and being otherwise duly advised in the premises, makes the following determinations:

1. On or about December 19, 2013, Daniel Bortnick, M.D. (“Licensee”) entered into a Consent Order with the Board for alleged violations of the Kansas Healing Arts Act, K.S.A. 65-2801, *et seq.* The Consent Order required Licensee pay a fine in the amount of \$1000.00. Licensee was to remit payment to the Board by January 1, 2014.
2. On or about December 19, 2013, Licensee remitted full payment in the amount of \$1000.00 to the Kansas State Board of Healing Arts.
3. Licensee has satisfactorily met all requirements of the Consent Order and has no further obligation for compliance.

**IT IS THEREFORE ORDERED** that Licensee is hereby discharged from all requirements of the Consent Order filed on December 19, 2013.
