COMES NOW the Kansas State Board of Healing Arts (“Board”), by and through its Executive Director, Kathleen Selzler Lippert, a duly authorized representative of the Board, in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501 *et seq.*, as amended, and upon due consideration of the agency record and applicable statutes and regulations, and being otherwise duly advised in the premises, makes the following determinations:

1. On or about April 14, 2014, Jay Dee Brumbaugh, P.T., (“Licensee”) entered into a Consent Order with the Board for alleged violations of the Kansas Physical Therapy Practice Act, K.S.A. 65-2901, *et seq.* The Consent Order required Licensee to attend and successfully complete a continuing education course for billing and coding provided by Coding and Compliance Initiative Inc., by September 1, 2014; and submit to the Board documentation evidencing completion of the continuing education course no later than September 15, 2014.


