**JOURNAL ENTRY OF SATISFACTION OF FINAL ORDER**

COMES NOW the Kansas State Board of Healing Arts (“Board”), by and through its Executive Director, Kathleen Selzler Lippert, a duly authorized representative of the Board, in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501 *et seq.*, as amended, and upon due consideration of the agency record and applicable statutes and regulations, and being otherwise duly advised in the premises, makes the following:

1. On or about May 16, 2016, in accordance with K.S.A. 2015 Supp. 77-537 and 77-514, and as authorized by K.S.A. 65-5510(a)(4), a Summary Order was issued ordering an indefinite suspension against the license of Lisa Bussell, R.T. (“Licensee”) for her violation of the Kansas Respiratory Therapy Practice Act. Licensee shall be Indefinitely Suspended until such time she provides to the Board documentation evidencing completion of twelve (12) contact hours of continuing education earned between April 1, 2012, and March 30, 2013, and until such time as she submits to the Board full payment of her civil fine of \$100.00, as by the April 15, 2013, Summary Order in KSBHA Docket No. 13-HA00081.
2. Pursuant to K.S.A. 77-542, the Summary Order notified Licensee that if a written request for a hearing was not filed within fifteen (15) days following service of the Summary Order, the Summary Order would become effective as a Final Order upon expiration of

the time for requesting a hearing.

3. On or about June 7, 2016, the Summary Order became a Final Order, and Licensee's license to practice as a respiratory therapist in the State of Kansas was suspended.
4. On or about June 14, 2016, Licensee remitted full payment of her civil fine to the Kansas State Board of Healing Arts.
5. In addition, on or about June 17, 2016, Licensee submitted to the Board documentation evidencing completion of twenty-four (24) contact hours of continuing education on approximately June 15 and June 16, 2016.
6. Licensee has satisfactorily met all requirements of the Final Order in KSBHA Docket No. 13-HA00081 and, therefore, has no further obligation for compliance.

**IT IS THEREFORE ORDERED** that Licensee is hereby discharged from all requirements of the Final Order filed on June 7, 2016.

**IT IS FURTHER ORDERED** that the suspension on Licensee's license to practice as a respiratory therapist in the State of Kansas is hereby terminated.

**IT IS SO ORDERED.**
