**FINAL ORDER TERMINATING LIMITATION**

**NOW** on this 13th day of June 2014, comes before the Kansas State Board of Healing Arts (“Board”) the request of Thomas Campbell Jr., OTA (“Licensee”) for termination of the monitoring requirement contained in limitation placed on his license by the Final Order issued by the Board on July 13, 2011. Licensee appears in person and *pro se*. Jane Weiler, Associate Litigation Counsel, appears on behalf of the Board.

Pursuant to the authority granted to Board by the Kansas Occupational Therapy Practice Act, K.S.A. 65-5401 *et seq.*, and in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501 *et seq.*, the Board hereby enters this Final Order in the above-captioned matter. After reviewing the agency record, hearing the statements and arguments of the parties, receiving evidence, and being otherwise advised in the premises, the Board makes the following findings, conclusions and order:

1. Licensee is licensed to engage in the practice of occupational therapy in the State of Kansas, having been issued License No. 18-00772.
2. On or about July 13, 2011, the Board issued a Final Order (“2011 Final Order”) granting licensure to Licensee with a limitation on such license.

3. The grounds for the limitation in the 2011 Final Order were prior criminal convictions **Confidential** during Licensee's participation in his occupational therapy assistant educational program.

5. The terms of the 2011 Final Order allowed Licensee to petition the Board for modification or termination of the limitation after successful completion of all requirements.

8. On April 24, 2014, Licensee submitted a request to the Board for termination of the monitoring provisions contained in the 2011 Final Order. The Board construes Licensee's request as a petition to terminate the limitation on his occupational therapy assistant license.

9. The Board finds that Licensee has satisfactorily met all requirements of the 2011 Final Order and concludes that termination of the limitation on Licensee's license is warranted in the circumstances.

**IT IS THEREFORE ORDERED, BY THE KANSAS STATE BOARD OF HEALING ARTS** that the LIMITATION imposed by the Final Order filed on July 13, 2011, is hereby **TERMINATED** and that Licensee shall have no further obligation for compliance.


