**JOURNAL ENTRY OF SATISFACTION**

COMES NOW the Kansas State Board of Healing Arts (“Board”), by and through its Executive Director, Kathleen Selzler Lippert, a duly authorized representative of the Board, in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501 *et seq.*, as amended, and upon due consideration of the agency record and applicable statutes and regulations, and being otherwise duly advised in the premises, makes the following determinations:

1. On or about November 2, 2015, Pat Dinh Do, M.D. (“Licensee”) entered into a Consent Order with the Board for alleged violations of the Kansas Healing Arts Act, K.S.A. 65-2801, *et seq.* The Consent Order required Licensee to pay the Board costs in the amount of \$2,425.00.

2. Further, the Consent Order required Licensee to successfully complete the continuing medical education programs:

- a. All sessions of the in-person 2015 4<sup>th</sup> *Annual Shoulder Course* offered by the International Congress for Joint Reconstruction (ICJR) from November 5-7, 2015.
- b. The *Physician Supervision of Non-Physician Providers* webinar offered by KaMMCO.

3. On or about January 12, 2016, Licensee remitted full payment of the Board costs to the Kansas State Board of Healing Arts.

4. On or about May 10, 2016, Licensee submitted to the Board documentation evidencing his successful completion of the aforementioned continuing education courses as required pursuant to the Consent Order.

5. Licensee has satisfactorily met all requirements of the Consent Order and has no further obligation for compliance.

**IT IS THEREFORE ORDERED** that Licensee is hereby discharged from all requirements of the Consent Order filed on November 2, 2015.
